This report covers the period from the last ESCIF Congress and Assembly of Delegates – May 2017 to the present in August 2018.

ESCIF Congress 2017 in Piran, Slovenia



In 2017, the annual ESCIF Congress was organised in cooperation with the Slovenian Paraplegic Association, Zveza paraplegikov Slovenije. The congress was held for the twelfth time and for the first time in Slovenia. The congress took a place in a beautiful and accessible hotel on the Adriatic coast, Dom Paraplegikov, which is well worth a visit for a summer vacation.

The theme of the congress was Roadmap after SCI. Following the same path?

This topic is very important to obtain a good quality of life of people living with SCI and to increase life expectancy with as little as possible SCI related problems during the course of life. To achieve this we must walk hand in hand with government and legislation, medical care and NGOs. In addition, other people living with SCI. Different European models were presented in the congress and the participants could share their experiences and views in different workshops.

ESCIF Congress grants

The idea of the ESCIF Congress grants is to cover congress registration costs and a fixed amount towards travelling expenses for one participant (plus assistant where required). Members were informed of the possibility to apply for a grant for last year's Congress; however, no member organisation took the opportunity.



To the Congress this year one organisation has applied for grants and the application was approved.

ESCIF Executive meetings

The Executive has most of the time this year due to illness been without the presence of the President, Jane Horsewell, like last year. We have also experienced, as well due to illness, some periods with absence from some members in the Executive.

The Executive has held one meeting "in person" in the course of the year: in Prague in the middle of October 2017 (together with a meeting with the organisers of the present Congress). As usual, a meeting has also been held in the days running up to the present Congress.

In addition, the Executive had a number of telephone meetings throughout the year and has been in regular contact via email.

Ambassador program

The Ambassador program originally came up as an idea during the strategy group meeting in October 2016. The Executive continued to develop the idea and it was launched in January 2018. The purpose of this program is to improve the communication within ESCIF. In practice, it means that the members in the Executive will keep in regular contact with all the member organisations through on-line meetings, mails and preferably a visit some time. The idea is to get to know one another a little bit better so that ESCIF and the members know a bit more about each other's hopes, dreams, challenges, projects and achievements.
