Approval of the minutes of the 7th Assembly of Delegates 25 May 2012

The minutes of the seventh Assembly of Delegates of ESCIF from 25 May 2012 were approved by the delegates.

Approval of the presidents report

The President's Report (or annual report) was sent to member organizations and delegates before the congress. It's approved by the delegates.

3 Presentation of the accounts

Jani Trdina presents the Balance Sheet and Profit and Loss account. The accounts have been sent to all members.

The reason why we seem to have made a bigger profit is because one sponsor paid the sponsorship for 2013 before Christmas 2012.

Frans asks what we plan to do with the money. On the one hand, it's good to have some kind of buffer if things go badly. But ESCIF does not have the policy of amassing money. We might go into ESCIF funds in order to go forward with one or the other of the future activities. For first time ever we have the possibility to go ahead with a project and think about funding afterwards.

There was the question whether we should change the auditor. The executive decided that because of the specialty of our association and since it's not so big we don't need to change it right now.
