1. Approval of the minutes of the fourth Assembly of Delegates ESCIF which took place on 14 May 2009

The minutes of the fourth annual meeting of ESCIF dated 14 May 2009 in Vienna are approved by the delegates.

2. Approval of the Annual Report 2009

The Annual Report presented by the President, Daniel Joggi, is unanimously approved. The written report can be read online at www.escif.org.

3. Presentation of the accounts 2009

Jani Trdina presents the Balance Sheet and Profit and Loss account. The profit for the year is Euro 19,789.47. Jani proposes that the balance be carried forward to the 2010 accounts. The accounts are unanimously approved and the profit will be carried forward to the 2010 accounts.

Question from a delegate from the Netherlands – Frans Penninx The host country of the congress has to cover the costs for the official duration of the congress, to find sponsors and organizes the congress and the transports from an to the airport. The congress fee is retained by ESCIF. This is an unusual arrangement! Answer of ESCIF President Daniel Joggi

In the beginning we received Euro 20,000 from the Swiss Paraplegics Foundation. To find sponsors was not really easy. As ESCIF is a young organisation it is absolutely necessary to get money to do basic work for ESCIF. Unfortunately we don't have sponsors to cover all our costs. Perhaps in the future when ESCIF will be more established we probably can find sponsors and we can change this.

4. Presentation of the auditors' report

The Report of the statutory auditors to the Assembly of Delegates on the 2009 financial statement is presented by Jani Trdina.

5. Approval of the accounts and discharge of the Executive
The Auditors recommend approval of the report. The Assembly approves it
unanimously.

6. Decision on membership fees

The annual membership fees remains at €350.

Question from the Executive Committee - A few countries are in arrears with their membership fees. What is the opinion of the delegates? After discussion the delegates decide that the Executive Committee should prepare a proposal for a change in the statutes so that members will either be excluded or lose voting rights. The proposal will be sent to the Annual Assembly of Delegates 2011.

7. Presentation and approval of the 2010 budget
Jani Trdina presents the budget for 2010. The Assembly approves the budget.

8. Election of the auditor

The Executive committee recommend Price Waterhouse Coopers (PWC) as auditors. PWC is unanimously elected.

9. Election of 3 members of the Executive Committee (President, Vice President and a board member)
