PARTICIPATION OF DPO'S

Convention on the Rights of Persons with Disabilities (CRPD), article 33 states that Civil society, in particular persons with disabilities and their representative organizations, must be involved and fully participate in the monitoring process on implementation of CRPD.

Committee on the rights of persons with disabilities in its General comment No. 7 (2018) determines the participation of persons with disabilities, including children with disabilities, through their representative organizations, in the implementation and monitoring of the Convention

NSIOS - NATIONAL COUNCIL OF DISABLED PERSONS' ORGANIZATIONS OF SLOVENIA

Nacionalni svet invalidskih organizacij Slovenije (NSIOS) as an umbrella organisation that represents 25 member associations with over 100.000 individual members.



The National Council shall be composed of all the representative and other disabled people's organisations which are the signatories to Memorandum of Association and Activities of the National Council of Disabled People's Organisations of Slovenia. The membership in the National Council may be granted to any disabled people's organisation wishing such membership which operates at the national level and submits a written application in which it expresses its consent with the mission, purposes, goals and tasks of the National Council laid down in Memorandum.

LIST OF ISSUES

NSIOS with its members monitored implementation of CRPD in Slovenia. After Slovenia sent its Initial Report to Committee NSIOS prepared own draft list of questions for the Committee to consider when adopting its list of issues, especially issues not being answered accordingly, or not being attended at all

Slovenia prepared reply to list of Issues and send it to the Committee.
